

TEXTURE HAIR ELEVATED AWARDS
T.H.E Collection Competition Official Rules

VOID WHERE PROHIBITED. TEXTURE HAIR ELEVATED AWARDS T.H.E Collection Competition ("Promotion") begins at 12:00:00 AM Eastern Time ("ET") on January 16, 2023 and ends at 11:59:59 PM ET on June 30, 2023 ("Promotion Period"). *The promotion contains a contest of skill ("Contest"). The computer clock of Sponsor is the official time-keeping device in the Promotion.*

1. **ELIGIBILITY:** The Promotion is open only to legal residents of the forty-nine (49) United States (excluding Arizona and Puerto Rico) and the District of Columbia, who are eighteen (18) (except Alabama and Nebraska 19 and 21 in Mississippi) years of age or older at the time of Promotion registration.  - **Phase 3 - Winner Announcement:** The Grand Prize Winners will be announced on or about October 8, 2023

3. **HOW TO PARTICIPATE:** To participate, go to <https://texturedhairelevated.com/> (the "Website") during the Contest Entry Period to gain access to the Contest entry form. Complete the Contest Entry form (required fields include: Collection Title, Full Name, Salon Name, and Email Address) with the true and correct information. You will also select the category in which you fall (outlined in Appendix A below) and upload all requirements as outlined below where indicated. Entries for "Up Next" must submit proof of having two (2) years or less as a licensed cosmetologist in order to qualify. If the entrant is enrolled in cosmetology school, school name and state is required at time of submission. If the entrant has graduated, a valid cosmetology license in the residing state is required at time of submission (if applicable) and must be issued on or after January 16, 2021. Upon completion of the Contest Entry form, you will then be asked to upload your submission including image collection in portrait format via your PC or mobile device (acceptable formats include JPEG, and must meet, but not not to exceed 300DPI or 5 MB), Artist Release Form(s) and Model Release Form(s). Finally, submit payment based on the chosen category (fees outlined below in Appendix A). Collectively, your Contest Entry form, image collection submission and release forms, along with your Entry Fee, will result in one (1) Entry into the Contest.

The same image collection can only be used across two (2) Categories. Please be sure to check that your entry meets the guidelines and regulations for the categories you are entering.

Submission Requirements

- Entries must show work demonstrated on natural hair, wigs and/or extensions that fall within the texture type 3-8 (texture type 3-8 outlined within [T.H.E. Texture Guide](#) here ([PDF](#) or [Word](#)). Please reference Judging Criteria (Section 4 below) for guidance. Every entry must include:
 - Three (3) final images* on one (1) or more models
 - One (1) before image of each model**
- Entries must meet the corresponding category guidelines & regulations (included below in Appendix A) in order to qualify
- A completed [T.H.E Artist Release Form](#) ([PDF](#) or [Word](#)) must be submitted per entry, and include hair color formulation(s) for each look for all color entries
- A completed [T.H.E Model Release Form](#) ([PDF](#) or [Word](#)) must be submitted per model
- Retouching of the hairline, color or shape is not allowed and will be subject to disqualification
- Moderate retouching of skin is allowed
- All images must be in portrait format
- All images must be in JPEG (.jpg) format
- All images must have a resolution of 300DPI (CMPI not accepted)
- *At least one (1) look must be styled natural and at least one (1) look must be thermally styled for THE Collection -Hairstyling, Haircut, Haircolor, Barber, LONS
 - Natural styling is defined as working with models with natural texture or natural texture of enhancements and product without the use of curling irons, flat irons, crimping irons, or wave irons (manipulation of texture using comb, rollers or rods is allowed)
 - Thermal styling is defined as styling using heat appliances like flat irons, curling irons, crimping irons, or wave irons
- **If utilizing wigs and/or extensions, an unstyled photo is required and texture specifications must be noted on the [T.H.E. Artist Release Form](#) ([PDF](#) or [Word](#))

By submitting an Entry, you represent and warrant that your Entry is original to you, that the Entry has not been previously published, has not won previous awards and that neither it nor its contents infringes upon or violates the rights of any third party, including any copyrights, trademarks, rights of privacy, publicity or other intellectual property. By submitting an Entry, you warrant and represent that you consent to the submission and use of the Entry in the Contest and to its use as otherwise set forth herein.

- a. Overall Look (20%)
 - 1. Advanced understanding of texture should be demonstrated through balance, symmetry and cohesiveness of the overall look.
 - b. Photography and Styling (20%)
 - 1. Submissions should display an overall sense of balance and symmetry. Aesthetic harmony and balance should be prevalent among final submissions. The hair should be the focus. Wardrobe should complement and enhance the overall look.
 - c. Hair Integrity (20%)
 - 1. Hair health and integrity should be maintained and reflected through technical ability without the use of creative photo effects.
 - d. Finishing Details (20%)
 - 1. Finishing details should display mastery as to not distract from the overall look (e.g., visibility of hair pins, hair extensions, fly-aways, uneven coloring, gaps/bald spots, etc.)
 - e. Vision (20%)
 - 1. Pushing the boundaries, interpreting global trends, and showing creativity.

Entries that do not contain all required entry information or are considered inappropriate for any reason are not eligible. The eighteen (18) Entries with the highest scores from the Judges will be deemed the potential Finalists. In the event of a tie, an additional "tie-breaking" a judge will be brought in to evaluate the tied entries, based on the Judging Criteria above. Sponsor reserves the right not to award all prizes or to choose fewer than eighteen (18) if, in its sole discretion, it does not receive enough eligible and qualified Entries. Potential Finalists must show proof of valid cosmetology license in their residing state where applicable.  - j. Vision (20%)

1. Pushing the boundaries, interpreting global trends, and showing creativity.

The six (6) Entries with the highest scores from the Judges will be deemed the potential Contest Prize Winners.
